Description: The Technology Specialist will assist the Technology & Communications Officer in planning and facilitation of faculty, staff and student training and development regarding use of technology and technology integration into the classroom. The Technology Specialist will provide curriculum on training for use of computers with educational activities; as well as curriculum for the purpose of instituting standards in computer use and its instructional applications in the classroom. They will also provide training on new and emerging technology and application as they become available to students, faculty and staff. In addition, the Technology Specialist will work with faculty, staff, and students to resolve technology related issues including but not limited to: hardware, software, application, and network connectivity.
